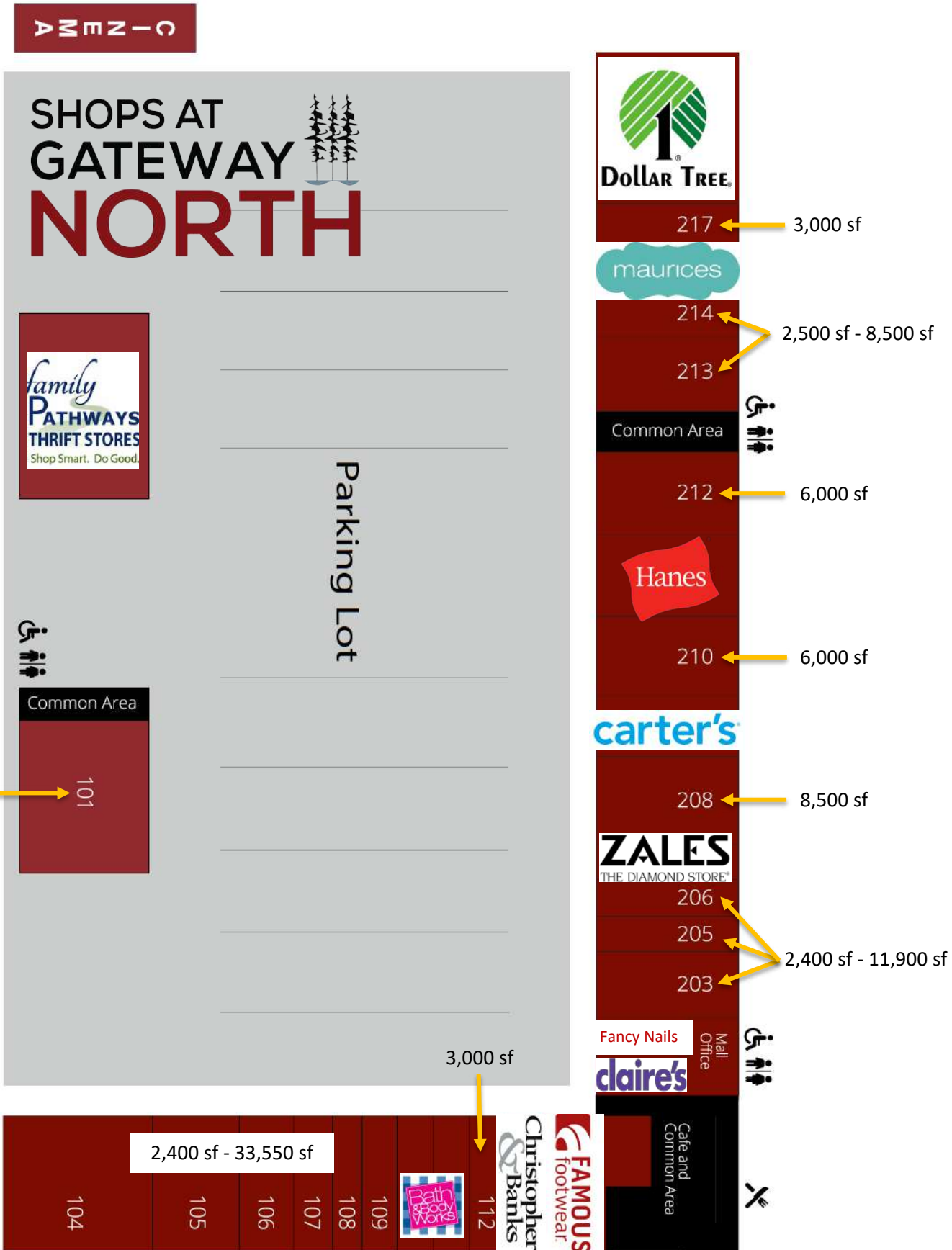

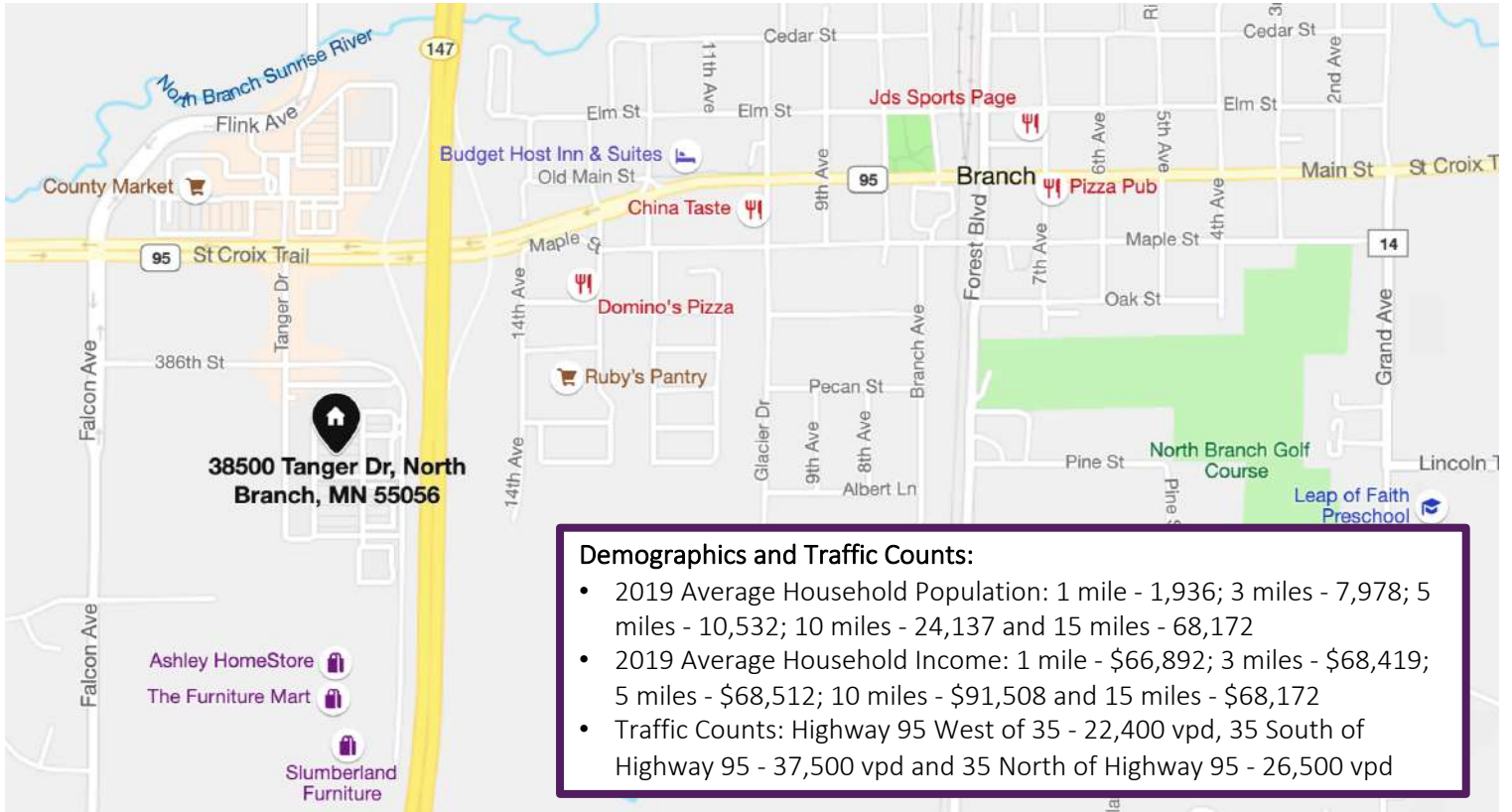
Site Plan
